Frequently Asked Questions.

Where can I get the UIL forms?

The coaches and front offices at Jordan and Wilder Intermediate Schools, Corbett Junior High School, and Clemens High School will have the release and medical history forms. You can also get them online by going to www.rankonesport.com or www.scuc.txed.net

Who needs a physical?

SCUCISD mandates that all students participating in Athletics during the 2023 - 2024 School Year obtain a physical before participation in any athletic class, practice, or game. Any athlete entering 7th-12th is welcome to attend pre-season physicals.

What should be brought/worn to the physicals?

The physical exam release and August Heart forms signed, as well as the medical history form signed. The \$15.00 payment must be paid via MSB. Tee-shirt and shorts (sports bras for females) are preferred for physicals.

Who Gets Completed Packets?

Packets completed on physical day will be taken up on site and kept at the high school. Physicals **NOT** done on this day will need to be turned into Coach Saunders or Coach Housby (Clemens Athletes), or the Junior High Coaches (Corbett Athletes).



Will transportation be provided to the physicals?

Students will be bused from Jordan, Wilder and Corbett to the physicals at Clemens. Jordan and Wilder students should be finished with physicals by 5:30 ish pm. Corbett students should be finished with physicals by 6:30 ish pm. Please be understanding as times may fluctuate. Students **MUST** be picked up from Clemens and are able to wait for their parents outside the Clemens event center. Phones will be made available for students use if needed.
